The successful individual will work as a part of the MOHW's Project Execution Unit on a contractual basis and report to the IS4H Lead — Project Execution Unit or designated alternate. The successful individual will also work collaboratively with other leaders from across the MiOHW and national health system stakeholders, as well as with other ministries and international partners. The successful individual will oversee and manage the implementation of a strategic change management plan to support the successful implementation and adoption of an electronic health information system in the community public clinics. This contract is expected to run for 24 months in the first instance commencing 1st August, 2022.

Main responsibilities include:

- Review and validate existing related products to prepare a Change Management Strategic Plan with Ministry teams, identify support needs and identify appropriate tools to support change management in the digital health space;
- Develop or verify an implementation plan for the prepared strategy;
- Conduct training sessions on change management models and techniques, aimed at the ministry team and/or actors involved in the digital transformation process.
- Managing the communications and views internally
- Creating and conducting the coaching and training sessions, including e-learning for various audiences, including customer management and leadership.
- Ensuring project goals are met and executed by working with numerous internal resources
- Mentoring and supporting team members on change management skills and assigning tasks where relevant

- Core and technical competencies: Demonstrable expertise and knowledge of change management methodologies; Demonstrate practical experience in supporting significant organizational change; Ability to acknowledge and address any client issues Selfmotivated individuals with energy and drive, able to work with little supervision and track multiple processes; Good interpersonal skills with the ability to interact culturally, linguistically, and diplomatically with diverse internal and external individuals; Good negotiation skills.
