**PRICE CONTROL ACT**  
**(CHAPTER 339)**

**PRICE CONTROL (GENERAL) (AMENDMENT)**  
**(NO. 2) REGULATIONS, 2018**

The Minister, in the exercise of the powers conferred by section 3 of the Price Control Act (*Ch. 339*), makes the following Regulations —

**1. Citation and commencement.**

- (1) These Regulations may be cited as the Price Control (General) (Amendment) (No. 2) Regulations, 2018.
- (2) These Regulations shall come into force on the 1<sup>st</sup> day of July, 2018.

**2. Amendment of the Schedule to S.I. No. 18 of 1973.**

The Schedule to the Price Control (General) Regulations is amended —

- (a) in Part 1 – Existing Items, by —
  - (i) deleting section 11 (Sugar) and its all of its contents in Parts A and B; and
  - (ii) deleting, under sections 1, 2 and 8 respectively, the maximum wholesale selling prices and maximum retail selling prices per package for product numbers “26”, “57”, “61”, “192”, “193”, “683”, “763”, “779” and “783” and substituting therefor the new prices for product numbers “26”, “57”, “61”, “192”, “193”, “683”, “763”, “779” and “783” as set out in Table 1; and
- (b) in Part 2 – New Items, by inserting the name of the product, brand and description and maximum wholesale and maximum retail selling prices of new items as set out in Table 2.
